8. Discuss and consider election of the Civil Service Commission Vice Chair in accordance with Chapter 143.006(e) of the Texas Local Government Code.



MOTION: Vice Chair Whitley made a motion, seconded by Commission Member Womack to adjourn. The vote was cast 3 for, 0 against.


