Receive and discuss a presentation from Jacobs Engineering Group [Planning Consultant] regarding the City's Comprehensive Land Use Plan.

This request supports the City Council 2013-2014 Policy Agenda.

Goal: Quality Development

Background

At the August 12, 2013 meeting, City Council approved a resolution authorizing the award of a contract to Jacobs Engineering Group, Inc. to provide an update to the City of Lancaster's Comprehensive Land Use Plan. The updated Comprehensive Plan is to identify community goals and objectives while also adding pertinent elements from existing plans and community input to make the plan comprehensive in scope. This Comprehensive Plan is meant to be the "umbrella" document guiding most aspects of the City's development and growth.

At the October 7, 2013 meeting, City Council approved a resolution accepting the Market Analysis Study from the consultants and directing them to move forward with meeting with the advisory board as well as conducting a community charrette on February 1, 2014.

Considerations

The purpose of the two joint work sessions are to review the research and stakeholder input received and completed to date, discuss the major issues and opportunities identified through this work, reach shared agreement on the most important ideas to pursue as the comprehensive plan process continues, and provide direction to staff to begin the next steps in the comprehensive plan process. Representatives from the Jacobs Engineering Group, Inc. team will give a presentation.

A workbook containing background and preparation materials for both sessions will be delivered to each Councilmember. The information is divided into Sessions A and B for each day. Council is asked to review the materials and make notes in the spaces provided to prepare for discussion and questions.
