Incident Report for Father Indicted on Capital Murder

Lancaster, TX – Please see the attached Incident Report regarding the arrest of Daniel Thomas, father of the victim, African American, female, approximately one year old. Thomas was booked into Dallas County Jail on capital murder charges on Wednesday, July 23, 2014.

On Sunday, July 20, 2014, at approximately 12:33 a.m. Lancaster EMS responded to an unresponsive child in the 1000 block of Woodcrest Drive. EMS attempted to resuscitate the child. The child was transported to Charlton Methodist Hospital and later pronounced dead.
