

## CITY OF LANCASTER

Minutes of Commission Meeting  
Monday, January 26, 2015

- Item 1—The Civil Service Commission meeting was called to order by Audley Logan, Civil Service Commission Chair Person, at 3:30 p.m. January 26, 2015.
